# Wiregrass Hope Group

## Statement of Faith

1. We believe the Scriptures of the Old and New Testament to be the Word of God, inspired by the Holy Spirit. I Thessalonians 2:13, II Timothy 3:15-17
2. We believe in God, eternally, existing in three persons: Father, Son, and Holy Spirit. John 10:30, Ephesian 4:4-6
3. We believe that Jesus Christ is the only begotten Son of God; conceived by the Holy Spirit, born of the Virgin Mary and is true God and true man. Matthew 1:23, John 1:1-4, I Corinthians 15:3-4
4. We believe that man was created in the image of God; that he sinned and thereby incurred not only physical death, but also spiritual death which is separation from God; and that all human beings are born with sinful nature. Genesis 1:27, Romans 3:23, 6:23
5. We believe God's plan for human sexuality is to be expressed only within the context of marriage, that God created man and woman as biologically unique. God instituted monogamous marriage between male and female as the foundation of the family and the basic structure of human society. For this reason, we believe that marriage is the exclusively union of one genetic male and one genetic female. Matthew 19:3-9; Mark 10:6-12 Romans 1:26-27
6. We believe the Lord Jesus Christ died for our sins according to the Scriptures as a representative, substitutional and complete sacrifice; and that all who believe in Him are justified on the grounds of his shed blood. Luke 24:46-47; Titus 3:4-7
7. We believe in the physical resurrection of the crucified body of our Lord Jesus Christ, His ascension into Heaven, and His present life there for us as our High Priest and Advocate providing a sufficiency for body, soul, and spirit for all believers. Acts 2:22-24; Romans 8:34
8. We believe in the personal, visible and Second Coming of our Lord Jesus Christ at a time unknown to us, but for which we are watching joyfully. Acts 1:11; Titus 2:13
9. We believe that all who receive by faith the Lord Jesus Christ are born of the Holy Spirit and thereby become children of God, and there is no other way to salvation. John 14:6; Acts 4:12
10. We believe that the believer should be a vessel sanctified for the Master's use. Matthew 22:37-39; Galatians 6:10
11. We believe in the Great Commission which our Lord has given to His Church to evangelize the world, and that this evangelization is the great mission of the church. Furthermore, we believe it's our Christian duty to witness by word and deed to these truths. Matthew 28:18-20; Acts 1:8

3. Wiregrass Hope Group is committed to integrity in working with clients, earning their trust, and providing promised information and services. We denounce any form of deception in corporate advertising or individual conversations with clients.
4. Wiregrass Hope Group does not discriminate in providing services because of race, religion, creed, color, national origin, age, marital status or handicap.
5. Wiregrass Hope Group is a totally prolife ministry in all cases. We will not advise, provide for, or refer for abortion or abortifacients.
6. Wiregrass Hope Group will not assess any fees for services rendered to its clients.
7. Wiregrass Hope Group does not engage in contraceptive counseling or in referring single clients for contraceptives. Married women seeking contraceptive advice and/or information shall be urged to seek counsel, together with their husbands, from their pastor and/or physician.
8. Wiregrass Hope Group is committed to professional excellence and encourages all staff and volunteers to perform their duties and responsibilities in a highly professional manner consistent with obedience to God's commands.
9. Wiregrass Hope Group will strive to foster in all staff, volunteers, and clients a primary concern for the spiritual well-being of their own families and recognize that establishing and maintaining a Christian home is the greatest contribution we will make throughout our lifetime.
10. Wiregrass Hope Group recognizes the validity of adoption as an alternative to abortion, but is not biased toward adoption when compared to the other life-saving alternatives. Any interaction with independent adoption agencies regarding referrals are made in a manner that fully protects the interests of clients and avoids any conflict of interest.

## Wiregrass Hope Group Volunteer Commitment

4. During the time I am volunteering with Wiregrass Hope Group, I agree to regularly attend a Christian church.
5. During the time I am volunteering with Wiregrass Hope Group, I will consistently live my life in a way that upholds Christian moral standards, including, but not limited to, refraining at all times from:
  - substance or alcohol over-use or abuse;
  - harassment of any type;
  - child or spousal abuse or neglect;
  - theft, fraud, embezzlement, corruption, bribery, misappropriations, or inappropriate removal or possession of property belonging to Wiregrass Hope Group, a co-worker, or a vendor;
  - sexual conduct outside the biblical covenant of marriage between a man and a woman;
  - malicious gossip;
  - physical aggression: fighting or threatening violence.
6. I have read, understand, and I am in full agreement with Wiregrass Hope Group's policies and procedures established by the Board of Directors.
7. I accept responsibility to act as an advocate on behalf of people to whom I minister under the auspices of Wiregrass Hope Group. I will keep ALL information concerning clients in STRICT CONFIDENCE, according to the policies of Wiregrass Hope Group, including after I leave volunteering with Wiregrass Hope Group.
